

### Supported Decision-Making: What is it?


<u>Supported Decision- Making</u>- "decision-making model in which an individual makes decisions with the support of trusted individuals" (American Bar Association)


# There is an expectation that people with DD have the opportunity to:


- Exercise maximum self-determination

   SELF DETERMINATION






Signs of Abuse		
<ul> <li>Physical:</li> <li>Multiple/severe bruises, welts</li> <li>Bruises which resemble an object</li> <li>Old and new bruises</li> <li>Signs of bone fractures</li> <li>Broken bones, open wounds, skull fracture</li> <li>Striking, shoving, beating, kicking, scratching</li> <li>Sprains, dislocation, lacerations, cuts, punctures</li> <li>Bed sores</li> <li>Individual is prohibited from being alone with visitors</li> <li>Individual has recent or sudden changes in behavior</li> <li>Restrained, tied to bed, tied to chair, locked in, isolated</li> <li>Prolonged interval between injury and treatment</li> </ul>

Signs of Abuse
<ul> <li>Sexual:</li> <li>Internal injuries</li> <li>Individual has recent or sudden changes in behavior</li> <li>Restrained, tied to bed, tied to chair, locked in, isolated</li> <li>Prolonged interval between injury and treatment</li> <li>Fear of caregiver or others</li> <li>Unexplained fear or mistrust</li> <li>Unwarranted suspicion</li> <li>STIs</li> <li>Genital or urinary issues</li> <li>Poor self- esteem</li> <li>Depression</li> <li>Self-destructive activity or suicidal ideation</li> </ul>




# Neglect Types of Neglect Neglect- not helping someone stay physically and mentally healthy Self Neglect\*- not making sure your basic needs are met (i.e. food, clothing, shelter, needed medical care, financial management) \*The most common type of substantiated reported abuse in Virginia for adults in 2021



Signs of Neglect
<ul> <li>Untreated medical condition</li> <li>Untreated mental health problem(s)</li> <li>Bedsores</li> <li>Medication not taken as prescribed</li> <li>Needs but does not have glasses, hearing aid, dentures, prosthetic device</li> <li>Malnourished</li> <li>Dehydrated</li> <li>Lacks needed supervision</li> <li>Lack of food or inadequate food</li> <li>Accumulated newspaper/debris</li> </ul>

### **Manipulation & Undue Influence**

Manipulation- to control or influence something or someone so that you get an advantage, often unfairly or dishonestly

Undue Influence- excessive persuasion that causes another person to act or refrain from acting by overcoming that person's free will and results in inequity




### Manipulation:


- · Individual feels fear, obligation and guilt
- · Individual questions themselves
- · Strings attached
- Specific techniques
- Example: Individual gives money/ resources they

cannot afford to give









### **Protocol for Addressing Abuse & Exploitation**

Supporters agree to not use their position to abuse, exploit, manipulate, neglect, or provide undue influence on the Decision Maker. Should you have concerns, discuss with the Decision Maker and contact Adult Protective Services, if needed. If abuse, exploitation, or neglect is suspected, contact Adult Protective Services and emergency services (911), as appropriate.


### **Roles and Responsibilities**


### Supporters

- Monitor for signs of abuse, neglect, and exploitation
- Do not use their position to abuse, exploit, manipulate, neglect, or provide undue influence
- · Discuss concerns with the Decision Maker
- If suspected, contact Adult Protective Services and/or 911

### **Facilitators**

- Same as Supporters above
- Monitor Supporters for signs of abuse, exploit, manipulate, neglect, or provide undue influence


<u>Suspected</u> abuse, neglect, or exploitation of adults with developmental disabilities.


### When are they required to report?


"A. Matters giving reason to suspect the abuse, neglect or exploitation of adults shall be reported <u>immediately</u> upon the reporting person's determination that there is such reason to suspect."  $\S$  63.2-1606
